Board of Management Meeting

Date: Saturday May 18, 2024

Location: Embassy Suites, Kissimmee, FL

Meeting convened by President Steve Fields at 1:04pm.

Quorum requirement met.

The agenda was accepted as presented.

Minutes of the previous meeting were approved as presented.

MOTION – Treasurer W. Richard "Dick" Young moved that: *The Florida Society shall establish an Ad Hoc Committee called the Congress Surplus Allocation Committee to evaluate proposals for the allocation of the remaining surplus congress funds and make recommendations to the next Board of Management for disbursement. The Charter of this committee shall be as follows:* The committee shall be established to receive and evaluate proposals for the use of the surplus funds from the 133rd Congress. The

committee may meet by email, Zoom, or in person. For a proposal to be evaluated, it must be submitted in writing or email to the chairman. Proposals shall include at least information on recipient, purpose, and explanation of how a distribution will benefit the Society, and who will be responsible for the application of any allocated funds.

The committee will remain in service until all surplus congress funds are allocated. The committee shall report their activities at each Board of Management meeting until its dissolution. The committee will consist of R. Richard "Dick" Young (chairman), W. Lee Popham, Kevin Shurte, Brad DeCody marble and Chris Washler.

Motion seconded by Stephen G. Hohman.

MOTION – The Financial Review Committee moved that the Committee Charter for that committee be updated as follows:

NAME: Financial Review

Status: Statutory

Purpose: To conduct, or cause to be conducted, an annual internal peer review of the financial books and records of the FLSSAR for

the preceding fiscal year

Authority: Florida Society By-Laws, Article V, Section 2

Members: The President shall appoint a Financial Review Committee of not less than three nor more than five Members of the

FLSSAR

Functions: The Financial Review Committee is responsible for conducting an annual internal review of the books and financial records of our Society. The Treasurer provides the committee with sufficient and appropriate material to review the activities, transactions, and financial assets of the FLSSAR. After reviewing the data, materials, and records provided, the Committee determines if those records and processes accurately reflect the financial position of the FLSSAR.

The report of such review shall be presented to the Board of Management for approval prior to the Annual Meeting of the FLSSAR. Since the motion came from a committee, no second is required.

James Ward moved to amend the Committee Charter by adding the following sentence to the charter: *The word "audit" is a reserved term and does not pertain to this charter.* The motion was seconded by Harry Rinker.

MOTION – Kevin Shurte, Chairman of The Education Outreach Committee moved to update the Charter of this Committee to read as follows:

Name – Educational Outreach committee

Status: Standing

Purpose: To administer the Florida Society portion of the NSSAR Education Outreach Program of the Education Committee.

Authority: Florida society By-Laws, Article V, Section 6.c

Members: A Chairman and additional Members, normally four, as the President, Florida Society may appoint and whose terms shall be concurrent with that of the appointing officer.

Functions: Coordinate with Education Committee of the NSSAR and others as directed to function as the "state-level society Education Outreach Coordinator" requested by the National Education Committee.

Work to establish an Education Outreach team leader at each chapter whose duties include:

- Implementing Youth Protection training, currently offered on the NSSAR website, for compatriots involved I education Outreach programs.
- Preparing Presenter Data Sheets for each presentation as prescribed by national and sending a copy to this committee.
- Reporting quarterly to this committee the name and number of presentations made by team members and the status of YPT program compliance.

Report state participation in education Outreach Programs to the National Education Committee.

Promote and support chapter participation in NSSAR Education Outreach programs.

Monitor and advise any chapter level initiative advocating for educational outreach.

Review and approve lesson plans and applications for the Youth education Medal to the state Medals and Awards committee. Take other action as authorized by the Board of Management.

The motion was seconded by Phillip Markoe.

MOTION – The Historic Sites and Celebrations Committee moved that the Florida Society create an ad hoc committee known as the First Amphibious Assault Memorial Committee for the purpose of establishing a monument in recognition of the first amphibious landing of the American Revolution. This committee will be funded with an initial \$5,000 from the general fund. It shall be called the First Amphibious Assault Memorial Committee.

CHARTR: The committee will establish an action plan and other recommendations not limited to, but including budgets, liaison relationships with partner organizations, design of the monument, site, promotional items, and advertising. The committee will report to each Board of Management (BOM) meeting and the Executive Committee on request. This committee will be established with the following members, and they shall serve until the BOM after the dedication of the monument or until a 2/3 vote of the BOM removes them. Additional members may be added to the committee by the incumbent president and confirmation of a majority of the Executive committee. These members shall serve under the same terms as the original appointees. Initial members shall be as follows: Steven Fields, Jonathan Hunt, W. Richard "Dick" Young, Earl "Matt" Matthews, Christopher Washler, and Steve DePaul, Chair.

Coming from the Historic Sites and Celebrations Committee the motion did not require a second.

PASSED

MOTION – The Education Outreach Committee moved to increase the 2024 budget line for the Education Outreach Committee from \$500 to \$1,500.

Coming from the committee, it did not require a second.

Steve Hohman moved to redistribute the Meek Award payout back to the participating chapters by dividing the number of new Fellows into the total award amount, and then assigning that value to each Fellow's participating chapter. Second by David Hitchcock.

The meeting was called to order by President Steen R. Fields at 3:13 PM Quorum was present.

Proposed By-Laws Amendments

Harry Rinker moved to forego the reading of the By-Laws amendments. Seconded by Steve Hohman' **PASSED**

Proposed By-Law changes:

The By-Laws Committee presented the following proposed by-laws changes, as published in the Spring 2024 Patriot Magazine and the Proceedings Book (Appendix C).

1. Appointment to State Positions of At-Large Members **Article III Officers, Section 3 Additional Offices**Summary of changes: Correct a typographical error--"of" to "or", and include a statement to clarify that a member who could otherwise be a member of a state chapter but does not elect to do so, shall not be appointed to a state-level office or committee.

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. **FAILED.**

2. Annual Elections Article III Officers, Section 2 Nomination and Election of Officers, C. Election

Summary of change: Clarify that voting for elected offices shall be allowed only by those members physically in attendance at the Annual Meeting.

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. **PASSED.**

3. Qualifications of Nominees Article III Officers, Section 2 Nomination and Election of Officers, B. Qualifications of Nominees: Summary of changes: Adds numbered paragraphs to the section. Clarifies that nominations for officers in lieu of slated positions shall only be made from the floor, that the nominated person does not have to be present, and that the nominating member has the responsibility to provide a signed document from the nominated person that he agrees to serve if elected. Adds a requirement that the nominating committee shall nominate only a single name for each elected office; no multiple nominations are allowed.

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented.

Randy Moody moved to remove the words "in person" from the suggested wording, B.2. **SECOND**. Will Wagner-Hart. PASED.

The motion, as amended, PASSED.

4. Schedule of BOM and Annual Meetings Article III Officers, Section 6 Holding Multiple Offices

Summary of change: Clarifies that the newly elected President cannot be part of any FLSSAR committee other than the Executive Committee, as prescribed by the By-Laws.

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

5. Number of Members Needed for New Chapter Article VII Chapters, 3. FORMATION

Summary of change: Increase the minimum number of members for a new chapter to 15.

The summer has come and gone in the 2024-2025 year and the Florida Society has been busy! Our committees have formed and, thanks to the energy and enthusiasm of our membership AND the "magic" of Zoom, are off to a good start.

In addition to going through my "initiation" into the role of President of the Florida Society I've had the opportunity to visit the Brevard Chapter for their annual SAR/DAR Flag Day celebration and the Withlachoochee Chapter meeting in September to congratulate them on bringing to the Florida Society the NSSAR Meek award for the most newly installed George Washington Endowment Fund Fellows.

The 134th Congress was held in Lancaster, PA in July. President General John Dodd was succeeded by our current President General Dr. Darryl S. Addington, MD. Compatriot Addington is a South Carolina native and currently lives with his wife Mary in North Carolina. Compatriot Addington joined the Sons of the American Revolution in 1996 and has served as a state president, National Trustee and Alternate Trustee, National Surgeon General, along with Treasurer and Secretary General. He has also served on the board of the SAR Foundation.

The Florida Society was well represented at Congress and especially by our Color Guard attendees. Your Society was equally honored and recognized with the presentation of many National awards. The actual presentation of the awards occurs once a year and takes but a few moments of time. The sweat equity, time and treasure that goes into earning those individual and group awards is a whole different order of magnitude. Kudos to all who contributed to making this happen.

Among the awards we brought home include: "The Florida Patriot", Florida SAR, Jeffrey L. Sizemore, Editor was awarded the Grahame T. Smallwood, Jr. Award for the state society of 500 members or more with the best news publication with more than 10 pages; The Florida Society was awarded the Walter Buchanan Meek Award to the Society which recruited the most new George Washington Fellows 2023-2024; the Walter G. Sterling Award to the State Society which enrolled the largest number of new members transferred from the C.A.R.; a Certificate of Appreciation in recognition of completion of Youth Protection Training by Leadership; the Carl F. Bessent Award to John L. Maier, Jr., Editor of "The Caloosa Patriot, Florida SAR for the most outstanding single sheet Chapter newsletter 2023-2024; and to the Florida Society, NSDAR the DAR/SAR Membership Award to the Florida DAR State Society with the highest percentage of recruiting approved SAR Members when compared to the SAR State Society's membership 2023-2024.

Equally rewarding was the Youth Awards Luncheon which recognized and presented cash awards to deserving individuals. The Florida Society was one of only 5 who had participation in all Youth categories, i.e., King Eagle Scout, Rumbaugh Orations, Knight Essay, Council of Youth Program Poster, Sgt Moses Adams Brochure, JROTC and American History Teacher.

Around the Florida Society: FLSSAR proudly sponsors three National events, The Battle of Pensacola, The Battle of Thomas Creek and the Last Naval Battle of the American Revolution. Energy and attention to details have laid the groundwork for The Battle of Alligator Bridge to continue to grow and hopefully become a fourth National event. On May 18, 2024, The Florida Society at its annual meeting approved the formation of an Ad-Hoc committee for the purpose of establishing a monument in recognition of the First Amphibious Landing of the American Revolution in which the Continental Marines came ashore on March 3, 1776.

Your Committees lead the way in keeping the Society on task, in focus and in the public eye. Notable examples are with the Education Outreach and working closely with FLDAR at Florida Fall Forum and equally important are the ongoing efforts at the grass roots level that reach into the communities and classrooms.

Now a look at the future...the Florida Society has quite a momentum going and we need to look at our respective committee goals and challenges for the rest of this year and into 2025. This is the time to review your committee charters, reaffirm your goals, set priorities and confirm due dates for report submissions.

The Florida delegation returned from Fall NSSAR Leadership held in Louisville, KY in time to prepare for the coming of Hurricane Milton. The Villages Chapter

MAY 26, 2024 – Five members of Villages Chapter SAR placed Memorial Day flags on graves at Bushnell National Cemetery on Sunday, May 26, and then seven members returned the following Saturday to pick up the flags. The 512-acre cemetery provides burial sites and/or memorial markers for more than 137,000 veterans and their spouses. The section we tend is #402.

JUNE 8, 2024 - Dr. Tom Davis told about the Youth Citizenship Awards that our chapter presented to five boys from The Villages Charter Schools: two to 5th graders (Middleton & Buffalo Ridge campuses), two to 8th graders (Middleton & Buffalo Ridge campuses), and one to a Senior in the Villages High School. We were glad to have our two 8th grade awardees attend our meeting today and be able to recognize them for their achievement. Citizenship Awards consisted of a certificate, a check in varying denominations that increase by grade, and a SAR America 250 challenge coin.

Our program was given by our chapter member, Lt. Colonel Donald Hansen, who spoke about "The Other Washington". William Washington was a distant cousin of George Washington, and about 20 years younger. William had trained for the ministry, but at the outbreak of the American Revolution, he was elected a Captain of Stafford County Minutemen on September 12, 1775, which was integrated into the Third Virginia Regiment in the early months of 1776. A very good leader and successful on the battlefields, William advanced through the ranks becoming a Major, Lt. Colonel, and ultimately a Brigadier General. At the Battle of Eutaw Springs, on September 8, 1781, Colonel Washington was severely wounded while leading a charge and was subsequently captured, ending his military service in the war. However, life as a prisoner of war wasn't all bad. William spent the remaining war years in Charleston, South Carolina, where he met and married Jane Reily Elliott. They had two children.

Don Hansen became interested in "the other Washington" when he learned that his fourth great-grandfather fought under William Washington during the Revolutionary War. (As a side note, you could not trace your Revolutionary War ancestry through George Washington, who had no children, but you could through William Washington!)
We had 47 people in attendance.

JULY 13, 2024 - Our guest speaker was Dee Collier who has a vast repertoire of historic characters she portrays in costume. Today she portrayed Deborah Sampson – the only woman to receive a soldier's pension for her service during the Revolutionary War! When a dear male friend was killed in the War, Deborah was so moved that in 1782, she disguised herself as a man, assumed the name Robert Shurtleff, and joined the Fourth Massachusetts Regiment. For a year and a half, Sampson's true sex escaped detection despite close calls. She was ultimately discovered in Philadelphia, when she became ill with a fever during an epidemic, was taken to a hospital, and lost consciousness. She received an honorable discharge on October 23, 1783, and returned to Massachusetts. On April 7, 1785 she married Benjamin Gannet from Sharon, Mass. and they had three children, Earl, Mary, and Patience. She received a military pension from the state of Massachusetts. In 1802 she decided to supplement the family income by going on a year-long lecture tour about her experiences, sometimes dressing in full military regalia. Deborah is the official heroine of the Commonwealth of Massachusetts, and her statue stands outside the Sharon, Massachusetts public library.

Our chapter took in two new members. Alan Greene joined as a new to SAR, and Robert Barlow transferred from North Carolina. Alan Greene spoke about his ancestry, stating that his 4th great grandfather, Ninian Beall, donated his farmland to George Washington as part of our nation's new capital!

We had 45 people in attendance.

AUGUST 10, 2024 - The Villages Chapter of SAR had an excellent meeting today with one of our own members presenting the program on "Who's on First? The Presidents before the President." Our own chapter member, Jere Greene, said the answer to the question of who was the first President depends on answering the questions: What do you mean by "first"? What do you mean by President? President of what? Jere told us that 14 men were President of the Colonies under the Continental Congress, between 1774-1789, before George Washington. Their average age when elected was 47, although one was as young as 32 (John Jay). All were "well off", and some were wealthy, but some of them lost nearly everything during the process of forming a new nation. Most were initially loyalists to the Crown when elected but later became "radicalized". The list of all 14 names is on one of the photos attached here. Most were President for one year, although Henry Middleton spent only 4 days as President. Intentional effort was made to spread the Presidents around over the colonies: Connecticut 1, Delaware 1, Maryland 1, Massachusetts 2, New Jersey 1, New York 1, Pennsylvania 2, South Carolina 2, and Virginia 3.

The first President elected by the Continental Congress was Peyton Randolph of Virginia; he was physically a BIG man and very wealthy – part of the reason he was selected. Henry Middleton was second and only served 4 days. John Hancock was third and served the longest term – a little over 2 years. The list goes on, but George Washington was the first person elected by the Congress to be President of the United States under the new US Constitution in 1789, and he served two four-year terms.

We had 54 in attendance and took in one new member, Michael Whitmore. Our Registrar, John Moore, told us that he often works with the John Bartram DAR Registrar, Diane Clemmons, on applications. Diane was attending our meeting and was introduced to the group.

SEPTEMBER 14, 2024 - Stewart Dunaway presented the program about "The Controversy of the Southern Campaign and Pyle's Defeat".

During the American Revolution, Col. John Pyle remained loyal to the British Crown. He received a commission as colonel of a Loyalist militia from the governor of North Carolina. In January and February of 1781, Pyle recruited a Loyalist force of men around his home near the Haw and Deep rivers. En route to join the larger British force under General Cornwallis, Pyle expected to encounter Col. Banastre Tarleton's dragoons, who were to serve as escorts to the main force. Both British and Patriot troops wore green jackets; British jackets had black trim, whereas Patriot jackets did not. When Patriot commander "Light-Horse Harry" Lee appeared in a similar attire as Tarleton, Pyle made the devastating mistake of allowing Lee's men to come within close proximity. A fight erupted between the adversaries. Lee and his men fell upon the Loyalists, killing nearly one hundred and wounding and scattering the rest. The event became known as Pyle's Defeat on February 25, 1781, which occurred near Alamance County, North Carolina. We had 48 people in attendance.

OCTOBER 12, 2024 – In October we will have Dr. Don Wyman presenting a program on the life of Benjamin Franklin: founding patriot, author, scientist, inventor, statesman, diplomat, printer, publisher and political philosopher.

Here are some other 2024 highlights that have occurred since the May 2024 Spring BOM:

- Throughout 2024, the Chapter continues its senior advisory support to the Swamp Fox Society C.A.R. As the Society ended its 2023-2024 program, on May 25, 2024, the Chapter made the first of its bi-annual contribution to help fund the Society's annual giving to numerous charities and other organizations qualifying under their Kids Helping Kids Program. Section 1 Membership

The membership of the BOM shall include only persons who are members in good standing of the FLSSAR, and who are listed in at least one of the following categories:

- a. persons who are lifetime members of the BOM by virtue of being a past President of the FLSSAR, a recipient of the Patriot Medal, or an incumbent or past elected officer of the NSSAR;
- b. persons who are members of the BOM by virtue of being, and while being, an elected officer of the FLSSAR; appointed incumbent FLSSAR Committee Chairman; an incumbent National Trustee from Florida; an incumbent Chapter President; and the most recent Past President of a chapter, i.e., the person who preceded an incumbent Chapter President in office; if a chapter has no most recent Past President it shall name another of its members to serve on the BOM;
- c. persons who have been appointed by chapters having more than forty members on the basis of one additional member of the BOM for each forty chapter members or fraction thereof more than the first forty, the term of office of such additional members of the BOM to be coterminous with that of the Chapter President incumbent at the time of their appointment to the

BOM.

A member of the BOM who is unable to attend a meeting may name, in writing, another member of the FLSSAR to attend and act in his stead; provided, however, that no person may have more than one vote. Members of the FLSSAR who are not members of the BOM may attend and participate in debate but may not vote.

- No proof submitted for one or more generations to connect lineage from one generation to the next.
- Incorrect check amount required for NSSAR and or FLSSAR fees and dues.

Recommended Application Submission Improvement Areas:

- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two people of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.

Included at the end of the BOM Proceeding Book are schedules that show the August YTD Cash Receipts and Expenses, plus the Year End Projection 2024 and the 2025 Budget.

Your Finance Committee has met a few times via Zoom to discuss and approve the 2025 Budget and the transition of the Society's accounting transactions to Quick Books.

The Quick Books transition has already started with the formation of a set of new charts of accounts for the "Statement of Activities" (aka as a Profit Loss Statement) and a "Statement of Financial Position" (aka Balance Sheet).

Annual Cost for Quick Books (QB) 2025 \$400.00, there will be a small cost to Quick Books in 2024 of about \$85.00 for printing of new checks and two months online fees. These online fees are based on the "Simple Start" version of Quick Books, which is their "basic" entry level QB.

If Quick Books is then approved by the Fall BOM the next step into Quick Books will start in early November, with a full go live as of January 01, 2025.

- Up to \$2,000 to be used to purchase the following materials to be used primarily by the FLSSAR Education Outreach Committee in their presentations to schools and other education related organizations.
 - 0 10'x10' SAR-Branded Pop-Up Canopy \$1500
 - o 8' Spandex SAR-Branded Table Cover \$ 350
 - 33"x81" SAR-Branded Retractable Banner \$ 150
- The balance of the 2023 Congress Fund, plus any unused cash from the above designated purposes, to be transferred to the FLSSAR Operating Budget Trust Fund for the future benefit of the Florida Society.

Education Outreach Committee

The FLSSAR Education Outreach Committee has been actively promoting youth programs, meeting 6 times over the past 6 months. Members have conducted surveys, attended and registered for conferences, and reached out to Florida SAR Chapter Presidents, coordinating their efforts to assist chapters in expanding youth education outreach across the state.

At the May 2024 BOM, members of the EOC presented the findings of their Spring 2024 Chapter Outreach Survey. The survey identified the chapters currently participating in education outreach and the contests in which they participated; Eagle Scout Contest participation was not included in this survey.

The survey results were as follows:

High School Essay	25%
Middle School Brochure	13%
Elementary School Poster	9%
Enhanced JROTC	9%
American History Teacher	9%
Oration	3%

Hoping to improve on this lackluster performance in the coming school year, EOC members made a motion at the Spring BOM requesting that members approve a budgetary increase from \$500 to \$1500 to cover the cost of print materials, conference registration fees, and promotional equipment. Thankfully, the membership unanimously approved this temporary spending measure.

On May 23-25, members of the EOC set up and manned a booth at the 36th Annual Florida Parent Educators Association (FPEA) Homeschool Convention at the Gaylord Palms Convention Center in Kissimmee, Florida. With the support of SAR members from various chapters, the committee distributed EOC contest literature, identified attendees interested in participating in our youth programs, and collected several names of youths and adults who requested information about joining C.A.R. and SAR. Following the close of this event, the EOC disseminated the contact information to 21 chapter presidents throughout the state, as well as forwarding C.A.R. and SAR membership leads to JoAnn Welker and Ray Lantz respectively.

After attending the 134th Congress in Lancaster, PA, the EOC completed a study of the South Atlantic District, focusing on the prize amounts each state within the district awards its various contest winners. Specific findings were shared with FLSSAR contest committee chairs, Treasurer Walter Arnold, Senior Vice President Chris Washler, and President Jim Gaskins. Overall, the surveyed showed that Florida is competitive in the poster and brochure contests and leads the district in prizes awarded to essay, oration, JROTC Enhanced, Eagle Scout, and American History Teacher contestants. Of special note was North Carolina's practice of recognizing teachers of winning students in the poster and brochure contests with cash awards.

Over summer break, the committee busily promoted and prepared for the upcoming 2024-2025 youth competitions. Committee members compiled and sent Youth Outreach Packets to all 32 chapters via email and U.S. Mail. The packets contained an At-a-Glance matrix of state contest submission dates and prizes as well as copies of the promotional contest fliers that were first unveiled this past May at the BOM. These writeable PDF fliers are now available on the FLSSAR homepage in the dropdown menu under the Education/Youth tab.

The EOC also registered for the 67th Annual Florida Council for the Social Studies (FCSS) Conference to be held at the Florida Hotel and Conference Center in Orlando on October 11-12. Whereas the FPEA Conference in May introduced SAR to Florida homeschoolers, the FCSS Conference will help to launch SAR youth programs in Florida's public schools. This event presents a valuable promotional opportunity for FLSSAR Education Outreach.

To bolster SAR's professional appearance at this and future events, the EOC purchased an 8'x3' horizontal banner and a 6' spandex table cover. The committee designed both display items to include generic FLSSAR verbiage thus lending their usefulness to any state event. Additionally, committee members purchased other exhibition materials out-of-pocket including acrylic sign stands, a self-inking SAR rubber stamp, and an 81" vertical retractable banner that depicts Washington crossing the Delaware and reads "Educating Future Generations."

Finally, the Education Outreach Committee submitted its 2024-2025 budget proposal to State Treasurer Walter Arnold. In its proposal, the committee requests that membership approve a budget increase of \$1500 dollars. This increase would allow the EOC to establish exhibition booths at the 2025 FPEA and FCSS conferences; this year the national society paid the \$685.00 registration fee for the FPEA event. The enhanced budget would also afford the committee the opportunity to set up a booth at the Florida Council of Independent Schools (FCIS) Convention, which the committee was unable to attend this year due to lack of funding. FCIS is "one of the largest accrediting organizations of independent schools in the United States" and affiliation with them would open access to private schools across the state (https://www.fcis.org/about/welcome-fcis).

The SAR Mission Statement asserts that one-third of our mission as a patriotic society is to educate and inspire future generations about our nation's founding principles. Thanks to the generous funding previously approved by our state membership, the EOC has been able to begin promoting our youth programs, planting promising seeds for future growth. Future investments will enable the EOC to nourish growth as we strive to fulfill our common mission of promoting Education Outreach Programs throughout the state.

SAR - CLUB EXPRESS HAS ARRIVED !!!!

We wanted to get out a quick update about the CLUB EXPRESS National Dues Billing Task Force project rollout. For those who don't know, CLUB EXPRESS is the Society and Chapter membership dues management and communication system that will allow Societies and Chapters to receive online dues payments for the 2025 dues cycle.

Several Florida SAR Chapters have already elected to join the Club Express system for the collection of dues, and for use as a Chapter communication system. Every Florida SAR Compatriot will soon receive an introductory email from Club Express, inviting you to create an account.

Please do not discard or disregard the Club Express email as spam! If there is any question about whether an email received from Club Express (or any other entity) with respect to the SAR is legitimate, please don't hesitate to contact your chapter president or Florida SAR Secretary Scott Breckenridge.

The creation of an account will be mandatory to use the system, as you will need to log in to your user account to pay your dues directly in Club Express.

Compatriots with the 2024-2025 school year starting to get underway, it would be a great time to engage with your local school systems to get involved with the many Youth Award Programs that we offer through the SAR. While I understand from some of our experiences some of the local school systems have been reluctant to get involved with our different programs. I would suggest that there are a couple of other avenues that we could explore to get the word out about our Youth Awards Programs and give the students an opportunity to participate. If your chapters are involved with your local DAR Chapters, Scouting Programs or other civic organizations, they offer us a great opportunity to introduce our Youth Awards Programs to both parents and students. I would also recommend looking into the local Home School Programs that are being offered within many of our communities. Most of the entries in all of our Youth Awards Programs this past year came from students that were being home schooled. In fact most of our State winners this year were home schooled students.

The 2025 Knight Essay Contest is currently underway with a deadline date of **31 December 2024** for the Chapter winners to be submitted to the FLSSAR State Chairman. Chapters need to establish their own particular deadline in order to complete the Chapter portion of this contest and then submit their winning essay to the State Committee Chairman prior to the 31 December deadline. All essays need to submitted through the closet FLSSAR Chapter to their location (Chapter locations and points of contact can be found on the FLSSAR website at flssar.org)

To participate students must submit an original 800 to 1,200 word essay based on an event, person, philosophy or idea associated with the American Revolution, Declaration of Independence, or the framing of the United States Constitution. The essays will be judged based upon its historical accuracy, clarity, organization, grammar, spelling and documentation.

The Chapter's winning essay must be submitted in five parts in the formats indicated as follows: 1. the Application (PDF); 2. the Bibliography (Word); 3. The Biography (Word); 4. The Essay (Word); 5. The Title Page (Word). This will allow the judges to finalize their evaluations of the essay; make any minor corrections as necessary; and submit our State winner to the national NSSAR committee by their February 2025 deadline. FLSSAR prizes for the 2025 contest are \$1,000/\$500/\$250. The NSSAR prizes presented at NSSAR Congress this year are 1st - \$6,000; 2nd - \$3,000; 3rd - \$2,000; 4th - \$500; and 5th - \$500. ROTC / JROTC Committee

Dale Bottom - Chairman

Following the May Board of Managers meeting, President Gaskins appointed the 2024/2025 ROTC Committee. The Committee consists of Rene Jewett, Miami Chapter; Doug Gibbens, Naples Chapter; Bill Hayes, Lake-Sumter Chapter, Bob McGuire, Charlotte Chapter; Jonathan Hunt, Caloosa Chapter; and Dale Bottom, Brevard Chapter; as Chairman.

President Gaskins asked the Committee to provide him with the Committee's 2024/2025 goals. The Committee agreed on the following goals:

- 1. Determine the high schools in Florida offering JRTOC and colleges and universities offering ROTC.
- 2. Identify any chapters that have a school offering JROTC and ROTC in their area that are supporting them with medals or other activities. Encourage chapter leadership to consider including ROTC support for any Senior ROTC programs in their area.
- 3. Encourage chapter JROTC leadership to contact the Primary Military Officer in each high school, offering their support.
- 4. Encourage every chapter to support every JROTC program in their designated chapter area. If it is not possible to have a presenter available for a JROTC Awards Program, at a minimum, provide a Bronze Medal and Certificate to be presented by the school.
- 5. Create a database, as it were, of Florida JROTC high schools and ROTC colleges and universities by Chapter location.
- 6. Emphasize the Senior ROTC program in colleges and universities. The various services rely on these programs for officers.
- 7. Encourage chapters to promote the Enhanced JROTC program. Participation dropped off during COVID and is slow to come back. In 2022/2023, seven Florida chapters entered a cadet in the Enhanced Program. In 2023/2024 there were only 3. With the number of great JROTC programs in Florida, we must do better than that. We should have a goal of at least 10 entrants. Florida has cadets that are the best and brightest in JROTC programs that are also among the best in the country and we should showcase them. In 2022/2023, the first-place winner in the State, from the Tampa Chapter, won National. The second-place winner, from Brevard Chapter, was so outstanding, he too would have won over all other state entries in the National Contest! Florida Society has had National Winners and National high placement candidates in past years and should continue to do so in the future.

The Committee's first effort has been to identify every JROTC and ROTC program in Florida Schools. So far as we can ascertain, there are: 170 Army, 77 Navy, 74 Air Force, 16 Marine Corps and 2 Coast Guard JROTC high school programs, for a total of 339 in Florida. Nineteen colleges and universities offer Army, Navy and Air Force Senior ROTC programs. Some may offer one program, some two and some all three. Their reach is extended to many more colleges and universities as they serve as hosts for other nearby schools' students that do not have Senior ROTC available.

The second effort has been to identify the Chapter Area in which the high schools offering JROTC programs are located. All thirty-two Florida SAR chapters have at least one JROTC program in their area. Using geography and guessing, the Committee developed a draft list of programs reasonably expected to be within each chapter area.

Each chapter's draft list was sent to the leadership of the respective chapter, asking them to confirm, correct or modify what was indicated for their chapter. About half of the chapters have confirmed their schools. If your chapter has not confirmed its list, we ask chapter leadership or the JROTC liaison do so. When that is achieved and the list is updated, we will have a complete list of JROTC/ROTC program by chapter area.

There are two "orphan" JROTC schools. The Committee is seeking a "home" for these programs, or another solution to make certain they receive SAR support.

Several Chapters support Sea Cadet programs and a small number also support the Civil Air Patrol and Young Marine programs. While organized differently from the JROTC, both programs provide similar leadership development opportunities and a wholesome environment for the personal growth of our youth to become better citizens.

The National ROTC Committee has recently approved a minor change in the rules of the Enhanced JROTC Program. The requirement that a cadet must be in the top 25% of his or her student body class is no longer absolute. The cadet now must be in the

"top 25% of his or her class or have a non-weighted 3.5 GPA in a 4.0 curriculum". The reason for this change was that there have been situations in which a very qualified nominee, in a very high-level high school, did not meet the 25% of his or her student body class hurdle. It was determined that a high GPA in those schools provided adequate evidence of sufficiently high academic achievement

National award levels have also been increased as follows; 1st Place \$6,000 (plus \$1,500 travel expense); 2nd Place \$3,000;3rd Place \$1,000; 4th Place \$500; 5th Place \$500. All other rules remain the same.

The Nomination Form on the website will be revised to reflect this change. Meantime, these changes have been communicated to all Florida SAR chapters by the ROTC Committee so they can be passed on to the Military Leadership in the JROTC school programs.

The Committee recognizes there are many demands on the time and efforts of Chapter leadership. The ROTC Committee appreciates your commitment to and support of the ROTC/JROTC and other Youth Programs.

Public Service and Heroism

The Public Service and Heroism Committee (PS&H) recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety, and Emergency Medical Services for their contributions to the community and for heroic acts with a commendation and medal. States, chapters and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.

The State-level PS&H Committee exists to publicize the committee's function to the states' local chapters and to encourage their participation. Awards presented are reported to the National-level PS&H Committee and the State-level society by filling out an online form. All Commendations should be reported prior to June 1, to ensure inclusion in the PS&H Committee Commendation booklet for distribution at the July NSSAR Congress. The fillable on-line Public Service & Heroism Report Form PDF forms may be found here. Some browsers use a default application to read PDF files and you may need to specify that the file be "opened" with the Adobe Reader application.

Note: Be certain to use the most current version of Adobe Reader for this form, as some web browsers have proprietary PDF readers that do not work with this form. Save and rename the file identifying your Chapter and name on your computer. Do not fill out the blank form on the above links. After saving the blank reporting form to your computer, open from your computer and fill out the form completely. Use the second button-bar at the top, right-side of the form labeled "Click to Save and Email," to save the completed form to your computer and simultaneously send the completed form to the PS&H Committee. If you do not receive a receipt confirmation

of the completed form in 3-4 days, contact the chairman of the PS&H Committee. One should also send the completed reporting form to their State PS&H chairman

This program is an excellent way to recognize deserving individuals in our community and the public sector. We do suggest that those individuals, in the public sector of Law Enforcement, Fire Safety, and Emergency Medical Services, who are being considered for a Heroism Commendation, be previously recognized by their division head for their heroism. Department heads generally welcome the opportunity to recommend deserving individuals for recognition. The commendations may be presented at either chapter meetings, departmental meetings, or other suitable events. The presentation of NSSAR commendations is an excellent means by which our Society can receive recognition and broaden our exposure and recruitment of potential new members. This program is also an excellent vehicle for publicity. The presentation of PS&H commendations at chapter and state meetings should be noted and reported by local media optimally; however, the recipient may elect not to have the commendation published for privacy concerns. Questions about the National SAR Public Service and Heroism Committee may be directed to a state's representative or the current chairman of the Public Service and Heroism Committee.

American History Teacher Award

(Tom & Betty Lawrence American History Teacher Award Committee) Kevin Shurte, Chairman

Following the 2024 Spring BOM, newly-elected FLSSAR President James Gaskins expanded the committee appointing three new members – Ronald Grove, Benjamin Tidwell III, and Hampton Allen, Jr. The committee met via Zoom on August 2, 2024, to discuss administration of the program for the coming year. Specific points of discussion included the 2025 committee budget, contest submission deadline, scoring rubric, and contest promotions.

The committee drafted, voted on, and submitted a 2025 budget proposal for \$1900 to State Treasurer Walter Arnold on August 4, 2025. This proposal includes \$500 cash awards for first-place winners of the middle and high school contests. The budget also extends cash prizes of \$250 and \$100 to the second and third place winners respectively. This extension is consistent with the newly-announced NSSAR policy that affords cash prizes to second and third place winners at both contest levels. The committee would allocate the remaining \$200 in the budget to cover Youth Luncheon meal expenses at the Spring 2025 BOM for the first-place contest winners and their plus-ones.

In accordance with its charter, the committee reviewed the 2025 calendar and established a submission deadline for the coming year. The committee approved that Chairman Kevin R. Shurte must receive all chapter entry packets that include the application, release form, 500-1000 word essay, and letter of recommendation on or before midnight on Friday, January 3, 2025. State Secretary Scott Breckenridge posted this new submission date under the Reporting tab on the FLSSAR member homepage.

For scoring contest entries, the committee agreed to continue use of the existing scoring rubric that considered the quality of the essay, curriculum vitae, and letter(s) of recommendation. However, new directives from NSSAR Education Outreach specify that essays are to be judged on the following five criteria:

- 1. Unique or innovative approach
- 2. Student excitement
- 3. Collaboration
- 4. Outside related activities
- 5. Goal for attending the conference.

In accordance with the National guidelines, greater value is to be afforded to criteria 1 and 5. Therefore, these new scoring guidelines will be implemented this contest year.

Hoping to increase interest and grow chapter participation in this program, the committee agreed to implement new promotional policies. The first change was the aforementioned restructuring of the prize matrix through the amended 2025 budget proposal. Secondly, members coordinated with the FLSSAR Education Outreach Committee to distribute chapter contest packets that promoted the various Education Outreach Scholarship Programs including the Tom & Betty Lawrence American History Teacher Award. Chapter presidents statewide received these packets via email and U.S. Mail. The committee also reached out to Secretary

Breckenridge who updated the FLSSAR website to include current contest information and uploaded the contest guidelines, application, and informational flyer under the Education/Youth tab on the public homepage.

According to our SAR Mission Statement, one goal of our society is "educating and inspiring future generations about the founding principles of our Country." Last year only nine percent of Florida chapters participated in this teacher outreach program. Today's teachers are a valuable conduit through which we can reach today's students and tomorrow's leaders. We challenge your chapter to identify, recognize, and reward one deserving teacher from your area "who distinguishes themselves in teaching the history of the American Revolution" (nssar.org).

Appendix A – Proposed Changes to the Standing Rules and Procedures.

Section 100 (Members)

Section 100, Regular Members, presently reads as follows:

A Regular Member is age 18 or older who pays annual dues. Only regular members may vote and hold office in the SAR and receive the Patriot Magazine for free.

Proposed Amended Section 100, Regular Members, revised as follows:

A Regular Member is age 18 or older who pays annual dues. All members, except Juniors, may vote at the Annual Meeting and hold office in the SAR—and receive the Patriot Magazine for free.

Justification:

The original text implies that Life, Active Duty, and Dual members cannot vote, and that is not the case. All members can vote only at the Annual Meeting. BOM meeting voting is restricted to BOM Members. The Patriot Magazine is no longer provided for free, except in electronic format.

Section 100, Dual Members, presently reads as follows:

A member in good standing may transfer to any other state society, subject to the acceptance of that body.

Transfer forms are available from state societies, National Headquarters, or the NSSAR web site. The Transfer form is sent to National Headquarters for registration once it is signed by the secretary of the state society of current affiliation and the secretary of the state society to which transfer is desired.

Proposed Amended Section 100, Dual Members, revised as follows:

Move to Section 100, Regular Members.

Justification:

This does not only apply to Dual members.

Section 100, Dual Members, presently reads as follows:

A member whose primary membership is in one state, and his current dues have been paid, and wishes to apply for dual membership in the Florida Society shall complete the upper half of form and send to the Treasurer of the Chapter with whom he will affiliate in Florida with a check for State dues, and the prevailing Chapter dues. The chapter secretary sends the form and two checks to the FLSSAR Secretary. Refer to the NSSAR website for current forms and fee schedules.

Proposed Amended Section 100, Dual Members, revised as follows:

A member whose primary membership is in one state, and his current dues have been paid, and wishes to apply for dual membership in the Florida Society shall complete the upper half of form and send to the Treasurer of the Chapter with whom he will affiliate in Florida with a check payment for State dues, and the prevailing Chapter dues. The chapter secretary sends the form and two checks payment for State dues to the FLSSAR Secretary. Refer to the NSSAR website for current forms and fee schedules.

Justification:

The method of payment need not be specified.

Section 105 (Regional Vice President)

Section 105, A.7, presently reads as follows:

Submit Quarterly reports to the BOM describing RVP visitations and service to Chapters – as well as information about chapter activities.

Proposed Amended Section 105, A.7, revised as follows:

Prior to each BOM Meeting, submit Quarterly reports to the BOM describing RVP visitations and service to Chapters – as well as information about chapter activities.

Justification:

BOM Meetings are no longer held quarterly.

Section 105, B.7, presently reads as follows:

Upon election to office at the Annual Meeting of the State Society, the State Secretary will provide each RVP with... 7. A supply of up-to-date FLSSAR letterhead and envelopes or templates.

Proposed Amended Section 105, B.7, revised as follows:

Remove from Section 105 (RVP), B.7 and from Section 106 (Secretary), j.7

Justification:

We no longer send letters.

Section 107 (Treasurer)

Section 107, 7, presently reads (in part) as follows:

7. Maintain a record of the name, location, and custodian of, and custody receipts for, items of furniture, office equipment, flags, amplifying and/or recording equipment, and other such property items owned by the FLSSAR including inventory of library books and documents.

Proposed Amended Section 107, 7, revised as follows:

Remove this item.

Justification:

This is a duty of the Sergeant-at-Arms, not the Treasurer.

Section 110 (Registrar)

Section 110, 1, presently reads (in part) as follows:

The Secretary shall keep a Register of the names and dates of election, transfer, resignation and death of all active members.

Proposed Amended Section 110, 1, revised as follows:

Move this sentence to Section 106 (Secretary).

Justification:

This is a duty of the Secretary, not the Registrar.

Section 122 (Vice President General South Atlantic District)

Section 122, presently reads (in part) as follows:

Once each four year period, the FLSSAR shall nominate a qualified member of the FLSSAR to the Annual South Atlantic District Meeting to be the nominee to the NSSAR for Vice President General of the South Atlantic District.

Proposed Amended Section 122, revised as follows:

Once each four year period, the FLSSAR Board of Managers shall nominate a qualified member of the FLSSAR to the Annual South Atlantic District Meeting to be the nominee to the NSSAR for Vice President General of the South Atlantic District. The nominee will be selected at the BOM meeting just prior to the Annual South Atlantic District Meeting.

Justification:

We've been doing this at our Annual Meeting. But usually the Annual South Atlantic District Meeting occurs before our Annual Meeting.

Section 123 (Fund Management)

Section 123, Endowment Trust Fund, presently reads (in part) as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Proposed Amended Section 123, Endowment Trust Fund, revised as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Justification:

The Board of Managers voted to discontinue this practice at the Fall 2023 BOM Meeting.

Section 500 (Rules of Protocol)

Section 500, Requests for Visits By the President General, presently reads as follows:

Please refer to NSSAR Official Handbook Volume II: History, Organization and Protocol and follow the section "Requests for visits by the President General."

Proposed Amended Section 500, Requests for Visits By the President General, revised as follows:

Please refer to NSSAR Official Handbook Volume on Protocol II: History, Organization and Protocol and follow the section "Requests for visits by the President General."

Justification:

This section is now in Volume IV. It could change at any Congress, so just leave it out.

Section 500, Wearing Medals, presently reads as follows:

The NSSAR Color Guard in July 2011 voted to allow the State Color Guard Commander to have the authority to allow or disallow the wearing of medals by Color Guard members in his Brigade. The Color Guard Commander in charge makes the final decision on the permission to wear medals on the Color Guard uniform during SAR internal events such as chapter, state and national meetings where the general public is not present. Therefore the Color Guard Commander makes that decision for all state meetings where the general public is not present. His decision for the color guard will also be in effect for other compatriots in uniform at all state meetings. Color Guard Commander Phillip H. Tarpley in August 2011 with the members support ruled FLSSAR Color Guardsmen could wear their medals (no miniature's) if desired under guidelines set forth by NSSAR policy. The members are to follow NSSAR protocol for placement of medals.

Proposed Amended Section 500, Wearing Medals, revised as follows:

1. Rename heading to "Color Guard Wearing Medals"

Justification:

This section only refers to the wearing of medals by color guard members.

2. The NSSAR Color Guard in July 2011 voted to allow the State Color Guard Commander to have the authority to allow or disallow the wearing of medals by Color Guard members in his Brigade. The Color Guard Commander in charge makes the final decision on the permission to wear medals on the Color Guard uniform during SAR internal events such as chapter, state and national meetings where the general public is not present. Therefore the Color Guard Commander makes that decision for all state meetings where the general public is not present. His decision for the color guard will also be in effect for other compatriots in uniform at all state meetings. Color Guard Commander Phillip H. Tarpley in August 2011 with the members support ruled FLSSAR Color Guardsmen could wear their medals (no miniature's) if desired under guidelines set forth by NSSAR policy. The members are to follow NSSAR protocol for placement of medals.

Justification:

While that may have been the policy at that time, it is no longer the case. As it notes, this is a decision for each Color Guard Commander, so it should not be specified here.

Section 502 (Registration and Hospitality Room)

Section 502, A.1, Regular or Special BOM Weekend, presently reads as follows:

The registration desk personnel have the responsibility of providing the BOM Proceedings (Blue Book), meal tickets, table signup sheets, meeting schedule, and any other informational items.

Proposed Amended Section 502, A.1, Regular or Special BOM Weekend, revised as follows:

The registration desk personnel have the responsibility of providing the BOM Proceedings (Blue Book), meal tickets, table signup sheets, meeting schedule, and any other informational items.

Justification:

This is no longer the "Blue Book".
